Policy highlights through the years

The Budget & Policy Center has long been proposing bold policies, publishing powerful research and analysis, getting our work in the media, testifying in Olympia, participating in and leading coalitions, and engaging in advocacy in our quest for shared prosperity. Below is some of what we've helped accomplish in collaboration with partner organizations, advocates, and community leaders:

Voters defeat Initiative 1033, thus 2010 protecting public sector jobs and community investments.

A Medicaid expansion for adults with low 2013 incomes supports public health.

The Early Start Act passes, bringing 2015 high-quality early learning to more children.

Voters pass an initiative to raise the state minimum wage to \$13.50 and provide sick 2016 and safe leave - so workers can make a better living and protect their well-being.


The governor vetoes a tax break for big manufacturers that would have siphoned money out of communities.

> The Washington Worker Relief Fund, which gives emergency payments to people who are undocumented, is created in the push for an equitable COVID recovery.

The Working Families Tax Credit and the capital gains wealth tax are enacted- and Temporary Assistance for Needy Families receives a funding boost – in a move to strengthen the tax code and jumpstart the economic recovery.

A conduit for policy leaders

Since 2010, nine Betty Jane Narver Policy fellows have made their mark on our organization!
