

# In first year of capital gains tax, 84% of statewide tax revenue came from wealthy households in King County

The capital gains excise tax is a critical source of funding for child care, early learning, and school construction across the state. In fact, in just its first year (2023), the tax raised nearly \$900 million in revenue by asking the wealthiest 0.2% of people in Washington, largely from King County, to pay a modest 7% tax on Wall Street profits above \$250,000 per year.<sup>1,2</sup> The largest ten payments alone totaled roughly \$502.3 million in tax revenue.<sup>3</sup> While the tax taps wealth that is concentrated predominantly in the hands of a few in King County, these resources help to ensure a brighter future for kids across Washington. **The data in this fact sheet shows statewide capital gains tax payments by county in Washington state.** (For data about payments by legislative district, [visit our accompanying fact sheet](#)).
