LEGISLATIVE AGENDA



Ensure access to child care for working families through the Working Connections Child Care program by eliminating the enrollment cap, increasing reimbursement rates for providers, and increasing wages for child care workers.



Support families in meeting basic needs while parents look for adequate and stable employment by restoring Temporary Assistance to Needy Families cash assistance, and make sure everyone can secure a roof over their heads through the Housing Trust Fund.



Ensure that 50 percent fewer people are living in poverty by 2025 through an intergenerational strategy focused on equity across all racial groups, family types, and geographies.

Give everyone access to nutritious food in Washington by investigating the scope and impact of hunger and food insecurity to allow state agencies and communities to develop targeted strategies to end hunger.

EDUCATION

Goal: Washington kids have access to a world-class education system with high-guality teachers, curriculum, and enrichment throughout early learning, K-12, and post-secondary education.



Ensure access to high-quality early childhood education through the Early Childhood Education Assistance Program by increasing slots in the program, making facilities improvements, and increasing the provider rate to support successful expansion.

Ensure every child has access to a great basic education, which includes recruiting and retaining great teachers and closing the opportunity gap for children of color.

Provide pathways to a post-secondary degree through the State Need Grant, Opportunity Grants, the Guided Pathways model, the College in Prisons program, and the Health Professional Loan Repayment Program.

HEALTHY PEOPLE & ENVIRONMENT

Goal: Washingtonians have equal opportunity to live healthy lives with access to affordable health care and clean air, water and land, as well as protection from the threat of climate change.



Preserve and protect Washington state's commitment to ensuring health care for all through the Affordable Care Act, Medicaid, and Apple Health for Kids.

Adopt a carbon tax to reduce emissions, accelerate a just economic transition to a green economy, and reduce the impacts of climate change on our communities and the environment.

Reduce toxic pollution in all communities through toxic site cleanups, programs to prevent and control harmful pollution, and grants for local communities facing toxic pollution and waste problems.

COMMUNITY DEVELOPMENT & TRUST

Goal: Washingtonians live in strong communities with a high quality of life, have opportunities to thrive, and are represented by a state government that is responsible, efficient, and transparent.



Ensure transparency and accountability in our tax code by requiring large corporations to disclose to the public the amounts they receive in state tax breaks, their gross income from activities performed in Washington state, and their bottom-line annual tax payments.

Guarantee that Washington residents have access to legal representation in civil matters such as discrimination claims, denial of public benefits, and other situations where they interact with the courts and government entities.

Incorporate an equity impact tool in policymaking to advance policies that will close the opportunity gap, and promote equitable outcomes for people of color, women, and children.

Reduce barriers to re-entry for people who have been incarcerated through the Fair Chance Act and legal financial obligations reform.

GREAT JOBS

Goal: Washington has a strong middle class with reliable employment and wages that allow Washington residents to support themselves and their families, upgrade their skills, and save for the future.



Ensure all Washington residents can take time off with universal paid Family and Medical Leave insurance.

Recognize and protect the right of people to organize and negotiate with their employers and raise wages for front-line workers by funding negotiated collective bargaining agreements for public workers.

REVENUE

Goal: Washington's revenue system is reformed to raise stable, dependable resources to fully fund public schools, to lift up working families, and to fund other priorities that serve us all.



Rebalance the tax code with a 9.9 percent tax on capital gains on the wealthiest 2 percent of Washingtonians.

Boost the incomes of more than 400,000 hardworking families in Washington state by fully funding the Working Families Tax Rebate.

Eliminate wasteful tax breaks and arbitrary restrictions that are harming Washington schools, while raising the state property tax levy to ensure every child has access to a great education.

Support homeowners and renters who work hard for low pay or are on low fixed incomes with new, targeted property tax rebates.
