


In first year of capital gains tax, 55% of statewide tax revenue came from wealthy households in a single legislative district

The capital gains excise tax is a critical source of funding for child care, early learning, and school construction across the state. In just its first year (fiscal year 2023), the tax raised nearly \$900 million in revenue by asking the wealthiest 0.2% of people in Washington, largely from King County, to pay a modest 7% tax on Wall Street profits above \$250,000 per year. The largest ten payments alone totaled roughly \$502.3 million in tax revenue. While the tax taps wealth that is concentrated predominantly in and around Seattle, these resources help to ensure a brighter future for kids across Washington.
